STORAGE CONTRACT

1. All environmental laws (B.M.P.'s) must be adhered to. **NO EXCEPTIONS.** I have received copy of the B.M.P.'s, and I have been given verbal instructions regarding them. I understand that any violation of the environmental regulations will result in immediate and permanent loss of boatyard privileges. ____ (Initial)
2. **DO NOT** move boat stands. There will be a **\$100 FINE** if you do. Only boatyard personnel can relocate supports (24 hours notice required/\$20 fee). Never tie anything (tarps, ropes, etc.) to the boat stands!
3. No "For Sale" signs are allowed on boats while stored in the boatyard.
4. No detached covering structures may be built, and **NO DIGGING** of any kind is allowed in the boatyard.
5. **NO MARINE REPAIR OR SERVICE CONTRACTORS ARE ALLOWED TO WORK IN THE BOATYARD WITHOUT OUR PRIOR WRITTEN APPROVAL (See list of "requirements" for marine contractors).**
6. **NO LIVEBOARDS, NO PETS, NO CHILDREN UNDER THE AGE OF 16, and NO VEHICLES** are allowed in the boatyard by the boats. (Parking is allowed only in designated parking areas only.)
7. **NO ELECTRIC HEATERS OR LARGE ELECTRICAL DEVICES ARE PERMITTED.** Only power for tools and batteries is provided. We **DO NOT** guarantee uninterrupted electricity, and we are not responsible for any resulting damage if the power fails. Note: **NO GRINDING** and **NO WELDING** allowed!
8. **CLEAN UP DAILY!** You will be charged at a rate of **\$75/hour for cleanup** if you neglect to do so.
9. A minimum of **72-HOURS NOTICE** is required for launching.

POLICIES

1. **Cash prices** are quoted for all services. 5% will be added to invoices with non-cash payments. ____ (Initial) ("Cash payment"=cash or in-state, first-party checks for amounts under \$1500, otherwise money orders.)
2. **NO CASH, NO SPLASH.** Accounts must be paid in full prior to launching. If the boat remains in the yard at the end of the month, you will be billed. If billed, payment is due by the 10th of the month. A \$15.00 late fee will be applied to accounts not paid in full by that date.
3. All boats and equipment are stored entirely at the owner's risk. Hylebos Marina Inc. is not responsible for the safety of your boat or its contents. Please remove all valuables from the vessel before your haul out.
4. Automatic foreclosure on any account three (3) months delinquent. (Hylebos Marina Inc. will take legal action to foreclose and sell the vessel for storage due if the account is more than 90 days past due.)
5. If Hylebos Marina Inc. is forced to take legal action to enforce this contract, I, the undersigned, agree to pay all attorney fees incurred by Hylebos Marina, Inc. in the course of ensuing litigation.
